| <p>Counterfeit Banknotes is an object in which material, size, color, image, and/or design resembles Rupiah which is made, shaped, printed, duplicated, circulated, or used as a means of payment against the law.</p> <p>Data on Counterfeit Banknotes is data and information gathered from the bank deposit examination of Bank Indonesia, Clarification Reports of Counterfeit Banknotes which are declared by Bank Indonesia, and counterfeit banknotes in banks reports which are declared by Bank Indonesia, as well as reports on the disclosure of counterfeit banknotes from the Police.</p> <p>Counterfeit Banknotes Ratio is a comparison between the counterfeit banknotes found per one Millions Currency in Circulation.</p> <p>Number of Counterfeit Banknotes by Region is a classification of Counterfeit Banknotes based on Province, which consists of Bali, Banten, Bengkulu, DI Yogyakarta, DKI Jakarta, Gorontalo, Jambi, West Java, Central Java, East Java, West Kalimantan, South Kalimantan, Central Kalimantan, East Kalimantan, North Kalimantan, Bangka Belitung Islands, Riau Islands, Lampung, Maluku, North Maluku, Nanggroe Aceh Darussalam, West Nusa Tenggara, East Nusa Tenggara, Papua, West Papua, Riau, West Sulawesi, South Sulawesi, Central Sulawesi, Southeast Sulawesi, North Sulawesi, West Sumatra, South Sumatra, North Sumatra.</p> <p>Annual data is the cumulative number of Counterfeit Banknotes during 1 year reporting period, while monthly data is cumulative Counterfeit Banknotes during 1 month reporting period.</p> | |

| <p>Counterfeit Banknotes data obtained from the findings of counterfeit banknotes from the examination of banks/non-banks deposits and the reporting of money exchange by the Cash Units at the Head Office and All Bank Indonesia representative offices, counterfeit banknotes reports from banks and public as well as reports from counterfeit banknotes cases by the Police.</p> <p>Collection and calculation process:</p> <p>The number of Counterfeit Banknotes is calculated from counterfeit banknotes reports that has been submitted by the Cash Unit at the Head Office and all Bank Indonesia representative offices and reports from counterfeit banknotes cases by the Police.</p> <p>Recording method:</p> <p>Data aggregation by region.</p> |
