DATA DEFINITION

Rupiah cash withdrawal transactions (outflow) contain information regarding flows of banknotes and coins from Bank Indonesia to the banking industry and public, consisting of commercial bank withdrawals, nonbank withdrawals, mobile cashier withdrawal services (currency exchange), cash custodian withdrawals at commercial banks and other withdrawals.

Outflow transactions in terms of cash custodian contain information regarding flows of banknotes and coins from Bank Indonesia to the banking industry and public regarding cash custodian at commercial banks.

Outflow transactions in terms of cash custodian are classified based on denomination, consisting of banknotes of Rp1,000, Rp2,000, Rp5,000, Rp10,000, Rp20,000, Rp50,000, Rp75,000 and Rp100,000 denominations, as well as coins of ≤Rp100, Rp200, Rp500 and Rp1,000 denominations. Rupiah is classified as large denomination currency of Rp50,000 and more as well as small denomination currency of Rp20,000 and less.

Outflow transactions in terms of cash custodian are also classified based on region, consisting of Sumatra, Java, Bali and Nusa Tenggara, Kalimantan as well as Sulawesi, Maluku and Papua.

Cash custodian incorporates activities to provide rupiah owned by Bank Indonesia to a commercial bank to replenish cash stock regionally and to meet public demand for currency.

Cash custodian is implemented by Bank Indonesia with the support of bank branch offices appointed as cash custodian administrators.
