Electronic Data Capture (EDC) machines are devices made for cashless payments using a debit card or credit card, with a direct connection to the user's bank account to debit the funds in real time.

Volume of EDC machine transaction represents the number of transactions processed via EDC machines.

Value of EDC machine transaction represents the value of transactions processed via EDC machines.

Electronic Money Reader is a machine used to read the data stored on an electronic money instrument, and is also used to perform purchase transactions, fund withdrawal and redeeming of funds.

Merchant is a seller of goods and/or services who receives payments from transactions that use Credit Cards and/or Debit Cards and/or Electronic Money.

On Us Transactions are non-cash transactions on EDC machines owned/managed by the card issuer.

Off Us Transactions are non-cash transactions on EDC machines that are not owned/managed by the card issuer.

Domestic transactions are the number of transactions within the territory of Indonesia in a certain period.

International transactions are the number of transactions outside the territory of Indonesia in a certain period.

METHODOLOGY

Collection and Calculation Method:

 Data concerning number of EDC machines, number of electronic money readers, number of merchants, volume of transaction volume and value of transaction is collected from the reports submitted online by banks and nonbank financial institutions issuers of ATM cards, ATM+Debit cards, Electronic Money and Acquirers via the Commercial Bank Head Office Report (LKPBU) and Nonbank Report (LSBU) applications.

Recording method:

- Data concerning number of EDC machines, number of electronic money readers and number of merchants represents the amount of machines at the end of the reporting period.
- Data concerning volume of transaction and value of transaction represents the accumulated volume and value of transaction data during the reporting period.
