<p>The Bank Indonesia – Real Time Gross Settlement (BI-RTGS) system is infrastructure used as a means to transfer funds electronically with real-time settlement on an individual transaction basis.</p> <p>RTGS participants are BI-RTGS system participants that meet prevailing requirements and are accepted and approved by the Operator as participants of the BI-RTGS system.</p> <p>Aggregate Volume of RTGS Transaction is total transaction activity (<b>frequency</b>) processed via the BI-RTGS system in a certain period.</p> <p>Aggregate Value of RTGS Transaction is the total value of transactions processed via the BI-RTGS system in a certain period.</p> <p>Volume of RTGS Transaction by Transaction Type is total transaction activity (<b>frequency</b>) processed via the BI-RTGS system in a certain period based on transaction type (categorised as customer transactions, interbank money market transactions, government transactions, monetary management transactions and other transactions).</p> <p>Value of RTGS Transaction by Transaction Type is the value of transactions processed in a specific currency (rupiah) via the BI-RTGS system in a certain period based on transaction type (categorised as customer transactions, interbank money market</p>	

transactions, government transactions, monetary management transactions and other transactions).
